## LIABILITY RELEASE

AS PART OF THE CONSIDERATION FOR MY BEING ENTITLED TO PARTICIPATE IN A WOODWORKING COURSE AT NE 1/4 SECTION 30, TOWNSHIP 34, RANGE 35, WEST OF THE 5th MERIDIAN, BOWDEN, ALBERTA, ORGANIZED, OPERATED AND INSTRUCTED BY PAUL BRODIE, I, THE UNDERSIGNED (HEREINAFTER REFERRED TO AS THE 'PARTICIPANT") HEREBY AGREE TO EXECUTE THE STANDARD LIABILITY RELEASE/INDEMNITY AGREEMENT AS HEREINAFTER SET OUT:

## STANDARD LIABILITY RELEASE/INDEMNITY AGREEMENT

The Participant acknowledges and agrees:

- 1. PAUL BRODIE [hereinafter referred to as "Brodie", which term includes his agents, organizers, members, volunteers, attendees, students, servants, employees, administrators, executors, heirs and trustees] is not responsible for any death, loss, injury or damage suffered by me, the Participant, regarding the woodworking course, including use of equipment, work shop facilities, accommodation, meals and all activities engaged in or on the Brodie premises (hereinafter collectively referred to as the "Course") arranged by Brodie for any reason whatsoever, including negligence, on the part of Brodie.
- 2. To assume all risks involved in participating in the Course and I expressly agree that Brodie is relieved of all liability for any damage, loss, injury or death, which I, the Participant, may incur or sustain of all and every type and description occasioned by Brodie.
- 3. To indemnify, save and hold Brodie harmless from all losses, damages, claims, actions, demands, penalties, liabilities and expenses, including legal fees, howsoever arising or incurred out of any action, actions or failure to act on my part, whether negligent or otherwise, and I, the Participant, further agree to pay to Brodie, or any party designated by Brodie, any sums of money which may be determined to be payable to such other party, which have arisen out of any action, actions, or failure to act on my part.
- 4. To abide and adhere to all rules and regulations, including instructions, verbal or otherwise, imposed by Brodie and my failure to do so may well result in my being expelled from the Course and/or the Brodie property. Such rules, regulations and instructions may be amended at anytime and from time to time by Brodie and I, the Participant, agree to be bound by any such amendment.
- 5. To wear the necessary safety equipment, or clothing, required for the Course, as provided by Brodie. In the event I am required, as a Participant, to purchase safety equipment, I agree to do so and to wear the same as required, at the Course.
- 6. To purchase personal insurance (at my option) should I wish to protect myself and my belongings from loss, damage, injury or death.

- 7. The Course requires the use of equipment, which may be hazardous to my well being and that of others if not used in a safe and proper manner, and I agree to take all precaution so as to minimize the risk involved with the use of such equipment.
- 8. Brodie shall not be liable for failure to perform any of his respective obligations, covenants and agreements with respect to the Course, if such failure is caused by one or more of the following events, namely: acts of God, or the enemies of Canada, fire or other casualty, war, disaster, riots, strikes, lock-outs, or for any other causes beyond the control of Brodie, or for any cancellation of the Course.
- 9. I further acknowledge and agree that I have read this Liability Release and that I am of the full age of eighteen (18) years and that I accept the above Disclaimer Clause by my signature.
- 10. The Participant is 18 years of age or older. I agree to provide photo identity and proof of age prior to commencing the Course. Brodie shall be entitled to retain a copy of my proof of identification for his file records.
- 11. This Agreement shall be ensure to the benefit of Brodie and be binding upon my heirs, executors, administrators, trustees, successors and assigns.
